RECOMMENDED COMPOSITION OF THE ACADEMIC COUNCIL AND ITS FUNCTIONS IN AN AUTONOMOUS COLLEGE

I. Composition:

- 1. The Principal (Chairman).
- 2. All the heads of department in the college.
- 3. Four teachers of the college representing different categories of teaching staff by rotation on the basis of seniority of service in the college.
- Not less than four experts from outside the college representing such areas as Industry,
 Commerce, Law, Education, Medicine, Engineering etc., to be nominated by the Governing Body.
- 5. Three nominees of the university.
- 6. A faculty member nominated by the principal (member secretary).

II. Terms of Members:

The term of the nominated members shall be two years.

III. Meetings:

The principal shall convene a meeting of the Academic Council at least once a year.

IV. Functions:

Without prejudice to the generality of functions mentioned, the Academic Council will have powers to:

- (a) Scrutinize and approve the proposals with or without modification of the Boards of Studies with regard to courses of study, academic regulations, curricula, syllabi and modifications thereof, instructional and evaluation arrangements, methods, procedures relevant thereto etc., provided that where the Academic Council differs on any proposal, it will have the right to return the matter for reconsideration to the Board of Studies concerned or reject it, after giving reasons to do so.
- (b) Make regulations regarding the admission of students to different programmes of study in the college.
- (c) Make regulations for sports, extra-curricular activities, and proper maintenance and functioning of the playgrounds and hostels.
- (d) Recommend to the Governing Body proposals for institution of new programmes of study.
- (e) Recommend to the Governing Body institution of scholarships, studentships, fellowships, prizes and medals, and to frame regulations for the award of the same.
- (f) Advise the Governing Body on suggestions(s) pertaining to academic affairs made by it.
- (g) Perform such other functions as may be assigned by the Governing Body.

DISCUSSION NOTES FOR AGENDA

Agenda Item 1: Implementation of Autonomous status to the Existing UG courses

The U.G.C. declared Autonomous status to the college from the Academic year 2016. So the college has constituted various Academic and Administrative bodies such as Governing Body, Academic Council, Finance Committee, Controller of Examinations that are needed for the smooth functioning of Autonomy. As per the guidelines of the U.G.C. the college seeks the approval of the Academic Council for the implementation of the Autonomy in all the existing UG Courses for the Second year students too from the Academic year 2017. Hence the matter is placed before the committee for approval.

Agenda Item 2: Conduct of examinations:

As per the XII Plan Guidelines of the U.G.C., an Examination Cell is constituted with one Controller of Examinations and two Assistant Controllers of Examinations. The Cell proposes to conduct examinations for the first and second year students.

In various Boards of Studies the allotment of External and Internal
Assessment for 3 rd and 4 th semesters is proposed to be 70%External and
30% Internal and this proposal is placed for approval.
However under the instructions of Commissioner of Collegiate Education,
Govt. of AP, it is proposed to introduce 60% external and 40% internal from
the academic year 2017-18 applying to the present first year UG courses.
The Examination notification period is proposed for 40 or 45 days before the
commencement of external examination. The proposal is placed for approval.
Two Internal tests (Written test and Co-curricular Activity like seminar /Group
discussion) are proposed considering the average of the two Internals for 3 rd
and 4 th Semesters. The proposal is placed for approval.
Two internal tests Written test and co-curricular activities like seminar/ project
) are proposed considering the cumulative of the two internals for 1^{st} and 2^{nd}
semesters. The proposal is placed for approval.

- □ Following the guidelines of CBCS, 40% is considered as minimum pass percentage for both Internal and External evaluation and this is *placed for approval*.
- Evaluation scheme for Practical is proposed to be; (i) Internal evaluation for
 50 marks in Semester 1 and (ii) External evaluation for 50 marks in Semester
 - 4. The scheme is placed for approval

Agenda Item 3: Proposal for moderation with grafting of marks

There is no inbuilt provision of automatic moderation.

The moderation by grafting is considered two papers in which the pass percentage is less than 40 with a maximum of three marks for both papers.

Grafting is a procedure in which the individual who has got less marks than aggregate in one paper will be adjusted with a maximum of three marks from the high scored paper of that student. (Ex: for an MPC candidate, if she has failed with two marks in mathematics she will be benefited from the other subjects where she scored higher marks). Grafting allows transfer of marks from donor paper/s to make up the deficiency of marks in the failed paper/s. The first potential donor paper is that in which highest marks have been obtained. If other donor papers are required, those will be considered on the basis of descending order of marks. It is to be noted that grafting will not change the aggregate marks obtained by the student. After the grafting, the failed paper will be marked as passed.

- a) The maximum number of marks that can be transferred from any donor paper is **three** marks only.
- b) Grafting procedure is limited to **two papers**.
- c) The transfer of the marks will be allowed from theory to theory or practical to practical papers.
- d) Grafting is allowed within the parts only:
 - a. Part-A = Languages.
 - b. Part-B = Foundation Courses.
 - c. Part-C = Subjects.

Agenda Item 4: Proposal for award of additional credits for a) sports achievements, b)extra Curricular activities and c) attendance

To motivate, encourage and reward student participation in sports, extra-curricular activities, and to make them regular in their attendance to classes, it is proposed to award additional credits.

- a) To award credits for active participation in **sports and games**
 - i)To award 1 credit for winners at Inter University, State level
 - ii)To award 2 credits at national level
- b) To award credits for extracurricular activities: for participation during the complete assigned period.
 - i)To award 1 credit for participation in NCC.
 - ii)To award 1 credit for participation in NSS.
 - iii)To award 1 credit for **social service** (certificate by a recognised trust or NGO).

The credits are awarded at the time of completion of the course.

- c) To award credits for regular attendance to classes
- i)To award 1 credit for attendance between 80-90%.
- ii)To award 2 credits for attendance with 90% above.
