

The first Governing Body meeting of D. K. Government College for Women (A), Nellore has taken place on 21-10-2020. After attaining the Autonomous status in 2016 the college could convene the first meeting of Governing Body only in 2019-20 for the reason that the Government has nominated its nominees for the Governing Body only in December 24<sup>th</sup> 2019. Consequently, the College could form the complete body with all the members only in 2020. After the formation of the Governing Body, the meeting could not take place in the normal way because of the onset of Covid-19 Pandemic in February 2020 in India.
