Ph.D. (Full - Time) : Minimum 3 years and Maximum 5 years

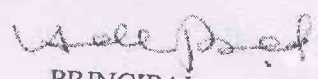

The duration of Ph.D. Programme shall be as follows (Clause 6.1 (b)):

Ph.D (Full-Time) : Minimum 03 years

Ph.D (Part-Time) : Minimum 05 years

The candidate should submit the joining report along with a copy of the fee receipt to the Principal, V.S. University College, Nellore under a copy to the Registrar, V.S. University, Nellore through the guide and the Head of the Department **on or before 10.12.2021**. In case the guide is from a department other than the department where registered, the Joining report is also to be forwarded by the Head of the Department where the candidate is registered and the candidate can use the facilities in the department of the guide.

The exact topic of research is to be finalized within **SIX MONTHS** in case of Full - Time candidate and one year in case of Part - Time candidates as per the procedure given in the Regulations and obtain the proceedings for the finalized topic from the Principal and communicate to the Controller of Examinations.

A full-time Scholar* shall not study any other full time course, or take up any occupation. He / She has to put in a minimum of 75% attendance every year and shall take the Ph.D Written examination after one year from the date of registration. Review of

progress report and attendance from the department through Guide and the Head of the Department (Clause 6.2). If any full – time scholar is continuously absent for three months without permission from the Guide and Head of the Department his / her registration stands cancelled. Candidate who is employed and registered as full time scholar has to submit relieving certificate at the time of admission.

The Candidate registered under Part-Time regulations shall be in contact with the Head of the Department concerned and the office of the Principal periodically for obtaining the particulars regarding the payment of term fee / examination fees etc.. He / She shall submit joining report, specifying the period for each stay through guide and Head of the Department concerned. He / She has to put in minimum of 30 days attendance in each of two consecutive years in the Department concerned and shall take the Ph.D. written examination after two years from the date of registration.

Note: 1. Hostel accommodation is not available.

2. If the candidate is a Post Graduate of other University and if the PG degree is not recognized by V.S. University already, he / she has to submit his / her PG syllabus along with migration certificate within one month of joining and get the degree recognized by V.S. University. If the degree not recognized by V.S. University, the registration gets cancelled.

3. Course work and Evaluation details are given in Regulations under Clause 6.

4. The date of reporting shall be the date of joining and annual tuition fee payable is accounted from the date of joining.
